Farnborough Aerodrome Consultative Committee TAG Information Report November 2007

1. Aircraft Movements

1.1 TAG's planning permission allows for 28,000 movements a year, of which up to 1,500 may be between 50-80 tonnes maximum take-off weight (MTOW).

1.2 Movements since the last meeting are as follows:-

2. Noise monitoring

2.1 The fixed Noise Monitoring Terminals continue to operate from their locations on the Runway 06 and 24 approaches. The portable noise monitor was, up until the 19th July, located in a variety of locations around the airport boundary for ground noise monitoring purposes. On the 20th July, whilst in location, the portable noise monitor was unfortunately damaged beyond repair during the flooding that occurred between 9:00 and 11:00 am. After assessment by the supplier an order for a new portable noise monitor was submitted. The new equipment has now been received and following set up and calibration process, it will be placed at the addresses of those local residents who made an appropriate request.

2.2 Modelling of all of the movements in 2006 and predicted movements for the calendar year 2007 was completed in February and reported in the last TAG Information Report in March. The July modelling exercise, in which actual noise contours for quarters 1 and 2 and predicted noise contours for quarters 3 and 4 were produced, was completed and submitted to Rushmoor Borough Council on the August 2007. Copies of the report were also supplied to Hart and Surrey Heath councils in accordance with the requirements of the Town and Country Planning Act Section 106 Agreement between TAG (as airport operator) and Rushmoor Borough Council (as planning authority). The next report is scheduled for February 2008 and will cover noise modelling of all actual movements in 2007 and predicted movements for the calendar year 2008.

3. Air Quality Monitoring

- 3.1 Air quality monitoring continues at 13 locations in Rushmoor and Hart. All results from the monitoring devices continue to indicate NOx levels that are below those expected for urban background sites. NOx monitoring results continue to show no indication of being influenced by airport operations. The active NOx monitoring devices have been absent during the 3rd quarter due to maintenance and recalibration. They have now been reinstalled at their original locations and active monitoring of NOx was resumed on the 1st October.

4. Runway Use

- 4.1 The predominant south westerly winds in the Farnborough area continued to favour use of runway 24, for the most part, from June to September. This predominance was particularly and uncharacteristically increased in July, during which the prevailing winds resulted in 44% of runway movements being accredited to 24 departures (compared to 37% recorded in July 2006). All recorded runway use and operation (i.e. Departure or Arrival) figures for the months of June, July, August and September are detailed below. A number of helicopters are subject to different procedures to fixed wing aircraft and do not require the use of the runway and ILS navigational aids, they are therefore classified as a separate percentage. Percentages of helicopter movements that have made use of the runway are also detailed.

5. New Development

- 5.1 The hearing of evidence regarding TAG's appeal against Rushmoor's decision with respect to redistribution of weekend movements took place over the 2nd, 3rd, 4th and 5th of April. The planning inspectors report has been submitted to the Secretary of State and a decision was expected by the end of October. It has since been confirmed that the Secretary of State is not bound by the statutory timetable set out in the Planning Inspectorate's letter and a decision on the appeal will therefore not necessarily be issued on or before the 31st October 2007. Assurance has been given that all efforts will be made to ensure a decision will be issued as soon as possible.

7. Complaints

- 7.1 The standard procedure of aircraft track monitoring continues with all movements audited in terms of aircraft track and altitude profile. The recording and investigation of all complaints received at the airport continues using the dedicated complaint line (01252 526001) which is now accessible through the main TAG switchboard number.

- 7.2 All aircraft and associated operators that fail to follow mandatory procedures without prior authorisation from Air Traffic Control are subject to further investigation. The standard procedure of contacting aircraft operators and requesting acknowledgement and details of action implemented to mitigate breaches of procedure continues. On occasion, aircraft are permitted to deviate from mandatory procedures by ATC. This cancellation of noise abatement procedures is only ever initiated when the maintenance of safety margins demands.

The number of noise abatement cancellations issued is being recorded and monitored using data provided by ATC.

- 7.3 Following debate at the last FACC meeting TAG continues to refine the reporting of complaints. Attached is a summary table for the period since the last meeting along with a more detailed report of complaints received and the details associated.
